GUIDELINES FOR COMPLETION OF THE ITA FORMS

Completing the Ideas to Action (ITA) forms is a valuable tool that allows you to review and reinforce what you’ve learned in class. It is an opportunity to apply the concepts you learned to real life scenarios and develop essential skills such as problem solving and critical thinking.

You must complete an ITA form for each education session you attend to be eligible to earn CMC or MMC education credit for that session. The FACC Professional Education Committee (PEC) recently updated the ITA to allow for more in-depth responses. Your answers must demonstrate a thorough understanding of the material presented and be written in paragraph form (minimum of 5 complete sentences per response.) We ask that you write these as if you were responding to your city/town/village manager or immediate supervisor’s request.

INSTRUCTIONS: Included in this “Packet” are “fillable” ITA forms for each educational session offered during this year’s IIMC Region III Conference. (All sessions except the keynote are eligible.) Read each question carefully and answer in a clear, concise, but thorough manner. You are expected to answer each question in paragraph form (**i.e., at least five complete sentences.**) If you attend a session that does not apply to your specific job, please answer the question as if it did. Remember to save your work periodically and always keep a backup copy of your ITAs.

Once your ITA packet is completed, email it to Amy Brewer (abrewer@fsu.edu) at the Florida Institute of Government no later than **Monday, January 27 by 5:00 pm.** ***We will send confirmation of receipt of your ITA within 24 hours.*** The FACC Professional Education Committee (PEC) will review all ITAs to ensure each form is thorough and complete. Those forms that are deemed insufficient or incomplete will be returned to the participant for revision, which will delay receipt of your Certificate of Completion with educational hours earned.
