

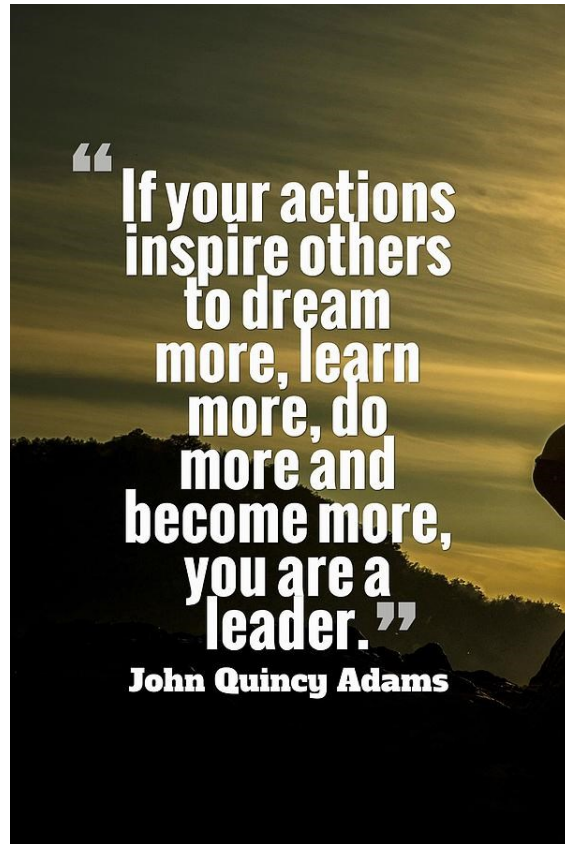

Hollywood, FL 33019.

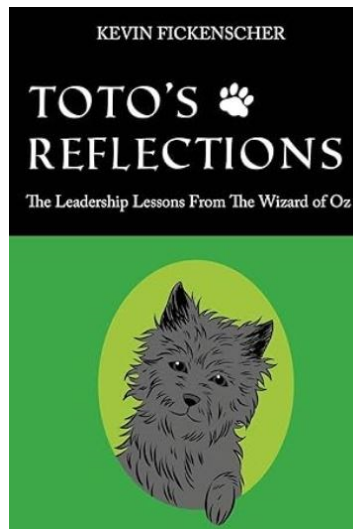
